Texas Department of Agriculture approved a Texas Community Block Grant application submitted by Uvalde County in November 2016, in the amount of \$350,000.00 to be used for the purchase of a fire truck. A check in the amount of \$350,000.00 was presented to Uvalde Fire Department for the purchase.

Carl Esser, of Esser & Co., updated on TxCDBG Knippa water and septic improvement project, which was completed ahead of schedule.
