## 1. Consider and act upon call to order, invocation and pledge of allegiance:

The Honorable William R. Mitchell Uvalde County Judge called the meeting of April 11, 2022 to order at 10:00 AM followed with the invocation, led the Pledge of Allegiance to the United States flag and Texas Pledge of Allegiance.

## 2. Consider and act upon approval of minutes:

Motion by Commissioner Bates to approve the minutes of March 28, 2022. Seconded by Commissioner Pargas. Motion carried (4-0).

# 3. Consider and act upon certifying Texas Hill Country River Region budget:

The office of the Uvalde County Judge received notification that Texas Hill Country River Region would not be able to attend this meeting. This agenda item will be considered at a later date.

# 4. Consider and act upon resolution prohibiting discharge of wastewater in area creeks, streams and rivers:

The Court considered a resolution in support of the Texas Commission on Environmental Quality rule change prohibiting the authorization of treated domestic wastewater pollutants discharged into any creek and stream located within the drainage area of the Frio, Sabinal or Nueces River.

Motion by Commissioner Bates to approve the resolution prohibiting wastewater discharge into the Frio, Sabinal or Nueces River.

Seconded by Commissioner Garza.

## 5. Consider and act upon request to consolidate polling precincts for May 7 elections:

Elections Administrator Melissa Jones requested the Courts approval of the consolidation of voting precincts 1, 5, 7, 8, 9, 10, 12 and 13 to vote in the Cactus Room at the Willie De Leon Civic Center located at 300 East Main Street, Uvalde, Texas 78801 and approval of Order of Special Election to be held on May 7, 2022 for the Constitutional Amendment Election and the joint City/School Elections.

Motion by Commissioner Garza to approve the voting precincts 1, 5, 7, 8, 9, 10, 12 and 13 consolidation to vote in the Cactus Room at the Willie De Leon Civic Center and approval of Order of Special Election to be held on May 7, 2022.

Seconded by Commissioner Bates.

## 6. Consider and act upon quotes for renovations to 524 East Nopal building:

County Consultant Carl Esser requested approval from the Court for renovation quotes to the District Attorney's office building located at 524 East Nopal Street. The quotes include; Painting submitted by NR Painting in the amount of \$2,100.00, Carpenter Installations submitted by Circle T Services in the amount of \$16,000.00, Floor Installation submitted by Circle T Services in the amount of \$15,000.00, Plumbing submitted by Coyote Plumbing in the amount of \$12,500.00 and Electrical submitted by Enrique Gallardo in the amount of \$14,995.36. All expenses are to be paid from Operation Lone Star Grant funding. Copies of all bids/proposals may be obtained from the office of the Uvalde County Judge William R. Mitchell.

Motion by Commissioner Bates to approve all quotes as presented for renovations to the District Attorney's office building located at 524 East Nopal Street.

## 7. Consider and act upon award of bids:

County Consultant Carl Esser outlined to the Court the sole bid received for the purchase of four (4) 2022 Chevrolet Blazer vehicles from Cavender Auto Country for the District Attorney's Office in the total amount of \$141,133.57 for all four vehicles to be paid from Operation Lone Star Grant funding. Copies of all bids/proposals may be obtained from the office of the Uvalde County Judge William R. Mitchell.

County Consultant Carl Esser requested consideration and approval from the Court on a resolution for submission of the fiscal year 2023 Community Project Funding Request to Congressman Tony Gonzales for funding under the Homeland Security Department Federal Emergency Management Agency, Emergency Operations Center Grants in the amount of \$1,000,000.00 for a new Emergency Operations Center facility for Uvalde County, Texas. Motion by Commissioner Garza to approve resolution in support of Community Project
