Judge Mitchell informed the Court that State statute now requires that Counties that have an average criminal disposition completeness percentage in DPS reporting of less than 90% to establish a Local Data Advisory Board by November 1, 2009. Uvalde County has a Juvenile reporting percentage of 89% and adult reporting percentage of 69%. The 81<sup>st</sup> Legislative Session passed HB 2730, which added Section 60.10 to the Code of Criminal Procedure.
