### 2. Consider and act upon approval of minutes:

### 6. Consider and act upon adopting 2016-2017 General Fund tax rate:

Motion made by Commissioner Scheide to increase the General Fund Property Tax Rate by the adoption of a tax rate of .49 cents and a debt service rate of .0885, which when included in the total tax rate, is a 25.19 % increase over the effective tax rate.

Seconded by Commissioner Bates.

Commissioner Flores stated that the current tax rate should be reduced to provide some relief to the taxpayers, since the increase in property values will increase taxes. He also stated that he could understand an increase to .63 cents, which would allow the revenue needed and also provide relief to taxpayers.
