

Notice of Public Hearing on Tax Increase

The COUNTY OF UVALDE will hold two public hearings on a proposal to increase total tax revenues from properties on the tax roll in the preceding tax year by 27.437722 percent (percentage by which proposed tax rate exceeds lower of rollback tax rate or effective tax calculated under Chapter 26, Tax Code). Your individual taxes may increase at a greater or lesser rate, or even decrease, depending on the change in the taxable value of your property in relation to the change in taxable value of all other property and the tax rate that is adopted.

The first public hearing will be held on August 24, 2009 at 10:00 AM at UVALDE COUNTY COMMISSIONERS COURT.

The second public hearing will be held on September 14, 2009 at 10:00 AM at UVALDE COUNTY COMMISSIONERS COURT.

The members of the governing body voted on the proposal to consider the tax increase as follows:

The average taxable value of a residence homestead in COUNTY OF UVALDE last year was \$78,615. Based on last year's tax rate of \$0.566200 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$445.12.

The average taxable value of a residence homestead in COUNTY OF UVALDE this year is \$81,909. If the governing body adopts the effective tax rate for this year of \$0.562000 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$460.33.

If the governing body adopts the proposed tax rate of \$0.716200 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$586.63.

Members of the public are encouraged to attend the hearings and express their views.

Special Provisions if Applicable

Criminal Justice Mandate (use for counties, if applicable):

The Uvalde County Appraisal District County Auditor certifies that Uvalde County Appraisal District County has spent \$0 in the previous 12 months beginning 07/01/2008, for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Uvalde County Appraisal District County Sheriff has provided information on these costs, minus the state revenues received for reimbursement of such costs.

Enhanced Indigent Health Care Expenditures (use if applicable):
