**ORDER SETTING MOTIONS, DISCOVERY & TRIAL SCHEDULE AND  
PRETRIAL NOTICE UNDER ARTICLE 28.01 C.C.P.**

The Court enters the following Setting Order upon defendant’s plea of “Not Guilty” at arraignment or upon appearance of counsel or the subsequent filing or pretrial motions:

Counsel for the defendant shall notify the defendant of all Court settings and, if the defendant is on bond, advise the defendant that he/she must be present on the dates and times specified in this Order. All settings in Medina County are in the 38<sup>th</sup> Judicial District Courtroom located in the Medina County Jail, and all settings in Uvalde and Real Counties are in the 38<sup>th</sup> Judicial District Courtroom in the county where the case is pending.

**ORDER REGARDING MOTIONS:** No motion may be filed without first conferring with opposing counsel and attempting to resolve the matter and including a certificate of conference on the motion which indicates the fact of the conference and the result thereof.

**SETTING ORDER**

**Date/Time and Description of Hearing Type and Activity:**

1. **ARRAIGNMENT: Date and Time as ordered in the Precept to Serve Indictment or Capias.** Appearance of defendant and counsel is required.
